## We're working near the A452, A45 and M42.

High Speed Two (HS2) is the new high speed railway for Britain. Since 2017, LM (Laing O'Rourke and Murphy & Sons Joint Venture) has been delivering initial works on phase one of High Speed Two (HS2) at the site of the new Interchange Station, which is located near the A452, A45 and M42.

## We're uncovering Britain's past.

Before we begin to build the new railway and the Interchange Station, the surrounding area will become part of the largest archaeology programme ever undertaken in the UK.

Across the HS2 route, more than 1,000 archaeologists, scientists and conservators are revealing the everyday lives of the people and their communities from the last 10,000 years.

## We'll be digging over 400 trenches.

From week commencing Monday 21 January 2019, we'll begin digging over 400 trenches, on HS2 owned land, around the A452, A45 and M42, and will continue until summer. This work will help us preserve any important discoveries, as well as effectively and safely prepare for our highways scheme.

## Our works won't affect highways in your area.

We'll dig a number of trenches per day, and explore each for a few days, before filling them back in if nothing is discovered. We'll work in one specific area at a time. Our working hours will be Monday to Friday, 8am to 5pm, with an hour set-up either side. Our works will not disrupt highways, traffic movement or building access in the area (see maps on pages 2 and 3).

Our works schedule is subject to change depending on site conditions, however we'll keep you informed of any adjustments.



We'll dig trenches in the areas shaded purple, in one specific area at a time.






**Key:**= permanent

### We're creating a Green Corridor.

We'll be carrying out vegetation clearance near the A452, A45 and M42 from early February, to prepare for the creation of the Green Corridor programme. The Green Corridor will be made up of new wildlife habitats, native woodlands and community spaces to help integrate the new railway line into the landscape and environment around it. To undertake these works, there'll be minor, temporary traffic management in the area which may include lane closures and traffic signals. Traffic controls will operate 9am to 3pm and have been designed to minimise disruption and maximise safety.

Further details of the traffic management programme will be shared before works start.
