

Notice of single lane closures on the B4438 and Northway

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by a joint venture between Laing O'Rourke and Murphy & Sons known as LM. In your area, we are working near the A452, A45 and M42, which surround the site of the future HS2 Interchange Station.

We're preparing for our future highways work

To help us accurately plan our future highways work in your area, we need to take a number of core samples to understand the makeup of the carriageway. We will drill small holes into the ground, to enable us to take a sample, and then refill the holes.

Recently, we also completed a new access road located off the B4438 to service a future compound. To ensure that road users know where this access road is, we need to install new road signage.

To conduct these works safely, we need to undertake a number of temporary overnight and daytime single lane closures.

We'll be starting work on 21 October

We will be carrying out temporary overnight single lane closures on the B4438 and Northway, from Monday 21 October to Wednesday 23 October, between 8pm and 6am (see map on next page).

We will also be carrying out temporary daytime single lane closures on the B4438, from Monday 21 October to Tuesday 22 October, between 9.30am and 3.30pm (see map on next page).

You may see our contractors on site up to an hour before and after those times.

This schedule is subject to change depending on site and weather conditions, but we'll keep you informed of any adjustments via: www.hs2insolihull.co.uk

Overnight working hours will be 8pm to 6am.

Daytime working hours will be 9.30am to 3.30pm.

We will only close single lanes on the B4438 and Northway, therefore those roads will remain operational throughout our works.

What we will do

Keep all sites safe and secure.

Ensure clear signage is in place to inform drivers.

Leave the area in a tidy state when works are complete.


Location of overnight single lane closures in your area Kev:
