Notice of surveys on the M42 between junctions 6 & 7

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by a joint venture between Laing O'Rourke and Murphy & Sons known as LM. In your area, we are working near the A452, A45 and M42, which surround the site of the future HS2 Interchange Station.

We're preparing to build four new highways bridges

During 2020, we will build four new highways bridges in the area that surrounds the future HS2 Interchange Station. All four bridges will be complete in early 2021. In the future, these bridges will connect the current highways network to the new highway routes we will create over the next two years. One bridge will be located over the M42 and another over the A446, as well as two bridges on the area of HS2 land surrounded by the A452, A45 and M42 where the Interchange Station will be built.

To develop the M42 bridge, we need to carry out surveys on the M42. The results of these surveys will help us plan our bridge construction by telling us the condition of the land and the location of nearby utilities. To conduct these safely, we need to install temporary lane closures.

We'll be starting work on 13 January

To carry out this work, we'll need to install temporary lane closures, for a few evenings at a time, between Monday 13 January to Thursday 30 January on the M42 between junctions 6 and 7 (see map on next page). You will be able to travel along the M42, in both directions, throughout our works.

We have planned lane closures on the M42

Our temporary overnight lane closures will be in place from:

- Monday 13 January to Wednesday 16 January
- Monday 27 January to Thursday 30 January

We will be working on site from 10pm to 5am each evening, but our contractors may be on site up to an hour before and after those times to set up and close down the site.

Duration of works

From Monday 13 January to Thursday 30 January.

Working hours will be 10pm to 5am, but our contractors may be on site up to an hour before and after those times.

What to expect

We will temporarily close lanes on the M42, between junctions 6 and 7, for a few evenings at a time in January. You will still be able to travel along the M42 in both directions.

What we will do

Keep all sites safe and secure.

Ensure clear signage is in place for drivers.

Leave the area in a tidy state when works are complete.

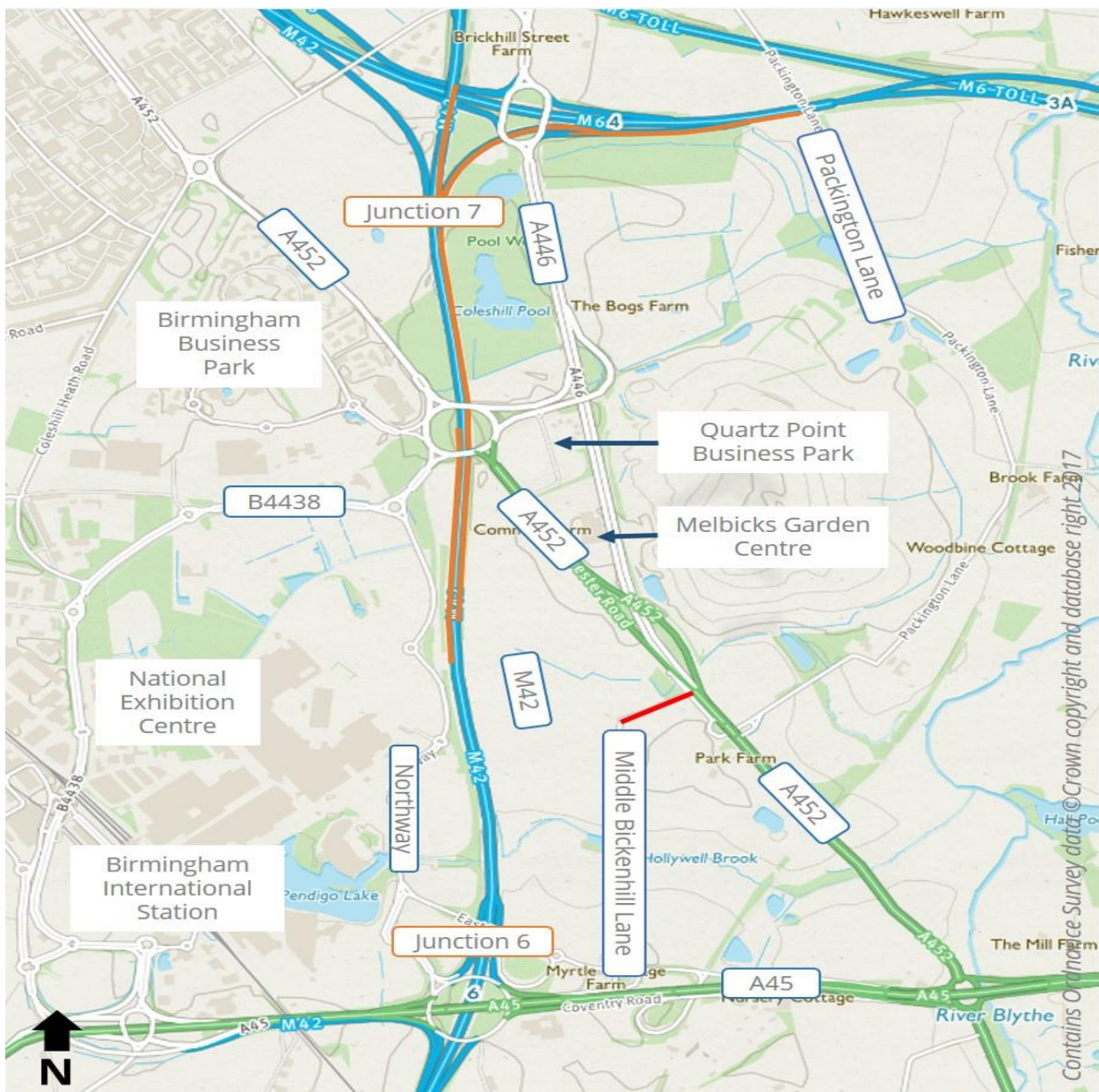
