

Notice of temporary traffic lights on Diddington Lane, Hampton-in-Arden

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are underway in your area, carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons. This notification is an update to one issued in March 2022 and is a continuation of works.

Temporary traffic lights

We will be carrying out some field reinstatement work along the Diddington Lane carriageway. In order to conduct this work safely, we need to temporarily install two-way traffic lights along a section of this road. The introduction of the temporary traffic lights will lead to a single lane, alternating, road travel movements between north and southbound traffic on the road.

Our work teams will be working in the area from 08:00 am to 6:00 pm each workday. The temporary traffic lights will be deployed from **09:30** am to **3:30 pm**. We expect to be on-site for up to three days.

Access to properties and businesses will be maintained and you will still be able to travel along Diddington Lane in both directions. Please see the map overleaf for more information.
