

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

#### The work we will be doing

BBV have been significantly reconfiguring the junction of the A446 Stonebridge Road and A452 Chester Road near Birmingham Business Park to facilitate the construction of a bridge that will take the new railway over the M42. On the night of 23 July, we will need to close the southbound slip road of the A446, known as Biddle's Loop, to install a temporary safety barrier and connect some new utilities. To minimise disruption to residents and business we will only close the road from 8pm at night and reopening at 6am in the morning. A fully signed diversion will be in place.
